DNR to host CWD public meeting in Waushara County

The Wisconsin Department of Natural Resources (DNR) today announced it will host a public meeting with the Waushara County Deer Advisory Council to provide information on chronic wasting disease (CWD) in Wisconsin, local testing efforts and disease surveillance options being considered. The meeting will be held at 6 p.m. on Monday, May 20 in Wautoma.

In February, the DNR confirmed the first positive test result for CWD in a wild deer in Waushara County. The deer was found dead in the town of Wautoma, which is within 10 miles of the Marquette and Portage county

CWD is a fatal, infectious nervous system disease of deer, moose, elk and reindeer/caribou. It belongs to the family of diseases known as transmissible spongiform encephalopathies or prion diseases. The DNR began monitoring the state's wild white-tailed deer population for CWD in 1999. The first positive test results were found in 2002.

Prepare now to boat safely this summer

The Wisconsin Department of Natural Resources (DNR) urges water enthusiasts to check boat equipment and review basic safety tips to prepare for the upcoming water season.

"Safety is an important part of water fun," said Lt. Darren Kuhn, DNR boating law administrator. "Wisconsin rivers and lakes can be relaxing and family-friendly places to spend a spring day when you put safety first and respect the water."

Check that your boat and trailer lights and safety equipment are in working order to save time and frustration at the boat launch. A full checklist of required equipment is available on the last page of the Wisconsin Boating Laws and Responsibilities Handbook.

It's also important to inspect your life jackets for wear and tear. Most inflatable jackets should be checked for leaks every six months, and the cartridge should be checked before each use. The jacket manufacturer's website should have instructions on how to check your life jacket status.





Keep bicyclists safe on the roadways May Law of the Month: Bicycle Safety

As summer approaches, we can expect more people to be out on their bicycles. In Wisconsin, bicycles are considered vehicles on the road, so they have the same rights and obey the same laws as motorists. The Wisconsin State Patrol reminds drivers and bicyclists to be aware of their surroundings and share the road to keep everyone safe.

Bicycles are harder to see on the roads and don't have the same safety features as vehicles, so riders are at greater risk of being hurt or killed in a crash. Bicycles are involved in an average of 705 crashes every year in Wisconsin. Seven bicyclists were killed in crashes in Wisconsin in 2023 and 699 were hurt, according to preliminary data.

"We want bicyclists to be able to enjoy the nice weather and take in the beauty of our state without fear of a crash," said Wisconsin State Patrol Superintendent Tim Carnahan. "Both motorists and bicyclists need to use extra caution and share the responsibility of creating safe roads for everyone to use."

Driver responsibilities:

- · If you see a bicyclist, slow down. The higher the vehicle speed, the higher the likelihood a bicyclist will be seriously injured or killed in the event of a crash.
- · Use caution. Bicycles have a smaller profile, so it is harder to judge their speed and distance.
- · Look twice for bicycles. Many crashes happen when drivers pull out from a stop sign, turn left or change lanes.
- · If parking along the street, always check the side mirrors and look back before opening doors. Opening a vehicle door into the path of a bicyclist can cause them to lose balance or flip over.
- State law prohibits motor vehicles from driving in a bicycle lane, except to enter a driveway, merge into a bicycle lane before turning at an intersection, or enter or leave a parking space located adjacent to the bicycle lane. Bicycles have the right-of-way.
- · State law requires drivers to stay at least three feet away from a bicycle.

Bicyclist responsibilities:

· Wear protective gear, including

a helmet.

· Obey all traffic laws, signs and signals.

 Be aware of your surroundings. Check behind you, especially when changing lanes. Keep an eye on vehicles when approaching intersections. Watch for opening car doors.

- · Be visible. Stay out of blind spots and use extra caution near larger vehicles like buses and trucks.
- State law requires bicyclists to use signals when turning or stopping. Signals may be given by a lamp or hand and arm.
- · Make it easier for drivers to see you. Wearing reflective and bright clothing. State law requires lights and reflectors during hours of darkness.
- The back of a bicycle must have reflective tape or a steady or flashing red light, and a white light is required on the front.

Understanding the signs of stroke in women

May is American Stroke Month. for strokes. Some women see their When women discuss their health concerns, stroke may not be near the top of the list. Experts say it should be.

According to the Centers for Disease Control and Prevention (CDC), strokes are among the top five killers of women, and one in five women will suffer a stroke between the ages of 55 and 75.

Nationwide, about 55,000 more women than men have strokes each year. Women also are more likely to die from strokes than men. Age plays a factor in that statistic. Since women tend to live longer than men, they are more likely to have a stroke.

Biological changes that come with perimenopause and menopause can also play a role. Health experts explain that the body stops ing or an uneven smile producing estrogen, women's risk for stroke and heart disease increases.

"Women face particular risks when it comes to stroke," said Dr. Thomas Mattio, a neurologist with Neuroscience Group and Medical Director of the ThedaCare Comprehensive Stroke Center. "They must understand their risk factors and know the signs so they can seek treatment as soon as possible,"

Understanding Stroke

Strokes happen when blood flow to an area of the brain is blocked or when a blood vessel in the brain bursts. This cuts off the flow of oxygen and nutrients to the brain and can lead to death or permanent damage.

According to Dr. Mattio, there are two main types of strokes. Ischemic strokes, the more common type, happen when a blood clot blocks or plugs an artery leading to the brain. Hemorrhagic strokes occur when blood vessels weaken and rupture under pressure.

When people survive strokes, they often face long-term disabilities, including problems with speech and body movements. Strokes also cause memory issues and put people at an increased risk of developing depression.

The CDC noted that high blood pressure is the greatest risk factor

blood pressure increase as they go through perimenopause and menopause as their estrogen levels decrease. Women should keep an eye on their blood pressure, make lifestyle changes, and take medication as needed.

Knowing the Signs

Everyone should recognize stroke symptoms. Awareness is essential, as the more quickly people receive care, the better the potential outcome.

The acronym BE FAST can help in remembering the signs of

B — Balance: Watch for sudden loss of balance

E — Eyes: Check for blurred vision or vision loss

F — Face: Look for facial droop-

A — Arms: Monitor for arm — or

– weakness S — Speech: Listen for slurred

T — Time: Call 911 right away If you or someone around you experiences these symptoms, call 911 immediately. Don't try to take the person to the hospital yourself. Time is critical because some treatments for stroke work only if given within the first three hours of symptom onset. A delay in treatment increases the risk of permanent brain damage or death.

Lowering Stroke Risk

"While strokes are serious, people can take steps to help decrease their risk," said Dr. Mattio.

People can lower their stroke

- risk by: · Controlling high blood pressure
- · Decreasing the amount of cholesterol and saturated fat in their diet
 - · Abstaining from tobacco use
 - Managing diabetes
- Maintaining a healthy weight Eating a diet rich in fruits and vegetables
- Exercising regularly
- · Drinking alcohol in moderation, if at all
- Treating obstructive sleep
- · Avoiding illegal drugs

While some stroke risk factors can be controlled, others cannot. Non-modifiable risk factors include:

- Age People age 55 or older have a higher risk of stroke than do younger people. However, anyone, at any age, can have a stroke.
- · Race or ethnicity Black and Hispanic people have a higher risk of stroke than do people of other races or ethnicities.
- Hormones Using birth control pills or hormone therapies that include estrogen increases risk.

Accessing Care

ThedaCare Regional Medical Center-Neenah is the region's only Comprehensive Stroke Center. This accreditation from DNV GL - Healthcare demonstrates the highest level of competence for treatment of serious stroke events. ThedaCare was awarded initial certification in 2019.

ThedaCare Regional Medical Center-Appleton is accredited as a Primary Stroke Center. This certification goes to hospitals that have the necessary staffing, infrastructure, and programs to stabilize and treat most emergent stroke patients.

ThedaCare Critical Access Hospitals in Berlin, New London, Shawano, Waupaca, and Wild Rose have all earned Acute Stroke Ready certifications. With this certification, smaller and rural hospitals must demonstrate excellence by complying with standards of care for the initial treatment of stroke patients, when rapid action and proper medications can save lives and limit the long-term disabling effects of strokes.

During this American Stroke Month, Dr. Mattio encouraged education and awareness.

"We want to support all people in taking positive steps to help reduce their risk of stroke," he said. "It's essential that each person knows the signs and seeks treatment if they or a loved one shows any stroke symptoms. If someone receives treatment quickly, it can provide opportunities for better outcomes."

Gardening Tips and Highlights

Container tomatoes

There is just nothing more satisfying than a juicy ripe homegrown tomato, which is arguably the best part of the summer. Fresh tomatoes are a far cry from the hard, pale, flavorless varieties that are in the grocery store.

For those with limited time and space, tomatoes grown in containers are a good option. They may need full sun, and many varieties don't need much space to grow. Examples of tomatoes that can be grown in containers include cherry or grape tomatoes. Even full-size slicers can be grown in pots on a sunny deck, or patio.

The best varieties to start with are determinate or bush varieties, because of their compact bushy growth habit. They grow no larger than three to four feet then stop. They also ripen around the same time. Cherry or grape tomatoes remain fairly small, they require little in the way of staking for support. Be sure to choose planters with enough room for growth. They start small, but fully grown they need space for a strong root system to develop.

It's best to wait until all danger of frost has passed before planting. When planting, plant deep in the soil, even up to the first set of leaves. Roots will form along the stem and make for some healthy root system. Add your staking material in the beginning as not to injure the roots later. It's a good idea to mulch the top of your pots to keep the soil moist and cool.

Make sure to water regularly. Soil should be kept moist throughout the season, as the soil in containers dries out faster than in the ground. Just push your finger into the pot, if the top inch of soil is dry, it needs a drink of water. Also, make sure the location gets plenty of sun.

At the end of the season, remove the plant and dispose of it, clean out the soil then wash the pot before storage, this way you'll be ready for next spring. Give it a try, there are many new varieties to look into and experiment with.





Amateur Radio bringing us together through communication

Amateur Radio (ham radio) is a popular hobby and service that brings people, electronics, and communication together. People use ham radio to talk across town, around the world, or even into space, all without the Internet or cell phones. It's fun, social, educational, and can be a lifeline during times of need. Local amateur radio instructor and test proctor George Lampere has been conducting a level-one technical class at the Coloma Community Center.

Although Amateur Radio operators get involved for many reasons, they all must begin with a basic knowledge of radio technology and operating principles, and pass an examination for the munications assistance FCC license to operate on for a major disaster,

radio frequencies known as the "Amateur Bands." One exciting new local association Mr. Lampere is involved in is the Marquette and Waushara FEMA-associated group to aid in emergency comsearch and rescue, and even the HERC help for hospitals.

Wayne Hutchinson of Hancock joined to better his skills as a CB user who also has a base station and specialized motorcycle radio. Dave LaShey of Neshkoro has previous

experience in amateur radio and wanted to get back into the hobby with a new license. John Menz of Dakota is working towards his professionallevel license to aid with emergency services.

If enough interest is generated for another

session with a threeperson minimum, Mr. Lampere will be offering classes and testing in the future. It is a fun hobby or a great public service way to get involved in your community. There are special interest groups within the ham radio realm such as satellites, or hundreds of more.

One such local group in called WAARN the Waushara Area Auxiliary Radio Network. Start a new group if you cannot find a specific interest connection, you have ham radio access not only to people within the U.S. but around the world!
